More recently, Preston served under President Bush in the Cabinet as Secretary of the U.S. Department of Housing and Urban Development (HUD) from 2008 to 2009. In response to the mounting mortgage crisis, he implemented an aggressive plan to improve Americans' access to mortgage capital, ensure disaster victims' access to housing, and rebuild public housing in New Orleans. HUD has 8,600 employees and a budget of over \$50 billon.

Prior to his Presidential appointment to HUD, Preston was Administrator of the U.S. Small Business Administration (SBA) from 2006 to 2008. Under Preston's leadership of the SBA, the organization significantly improved Federal programs which assist disaster victims and small businesses and implemented the most extensive employee development initiative in the agency's history.

SBA was rated "Most Improved" among large federal agencies in the "2008 Best Places to Work" survey conducted by the Partnership for Public Service and American University's Institute for the Study of Public Policy.
